Approval of August 27th, 2019 Council Minutes: The Council reviewed minutes from the August 27th, 2019 meeting and found no noted changes.

Monitoring:

- Six temperature sensors were retrieved from Upper Willow Creek. Flow in Willow Creek was 0.5 cfs on 11/18/2019. Data will be sent to ODA. Jenn Mickelson will send USFS stream monitoring data to Jenna.
- The MDWC is a stakeholder member in the Pesticide Stewardship Partnership and will continue collaborating with Sam Rossi with JSWCD on monitoring efforts.

Restoration:

- Upper Trout Creek Tributary Rehabilitation proposal submitted to OWEB in late October 2019, follow-up conference call with OWEB reviewers late November 2019.
- Project completion: Upper Willow Creek fencing on Newbill Creek

 - Update 2020 MDWC Action Plan and include measurable deliverables
 - Update by-laws, outreach plan, educational policies, BoD alternates
 - MDWC in need of vehicle, Jenna will ask local dealerships for donation; potential for PGE to donate used fleet vehicle. NRCS can provide short-term car access.
 - Research new funding opportunities
 - PGE Tour of SWW in April/May for board meeting

- Work towards a MDWC Agricultural Water Quality Monitoring Plan (submit OWEB monitoring proposal Fall 2020)
- Establish photo-point monitoring at Ingraham Meadow (Madras High?)

Restoration:

- Meet with Trout and Upper Willow Creek Landowners to discuss future projects and workshop ideas
- Plan Invasive Weed Treatment Redband Ranch communicate with Tom Laird (weeds coordinator with Jefferson Co.)

o Other

 Further research if Watershed-Reserve Ag certification is possible (pro-Agriculture standpoint), highlight landowners and tie into National or Regional meetings for recognition

Partner Updates:

- Theresa DeBardelaben (ODA): Theresa attended the SWCC meeting this month and learned
 of a potential resort planned nearby, advised MDWC meeting attendees to talk to planning
 department of nearby cities if interested learning more.
- Sam Rossi (Jefferson SWCD): Sam submitted a technical assistance grant to OWEB to fund the beaver-dam-analog design process in Campbell Creek. This project focuses on off-farm restoration approaches. A site visit with OWEB is scheduled for 12/6.
- Lars Santana (NRCS): The NRCS has secured a computer, IT support, printing, and server
 access for Jenna for one year. PL566 piping project is happening around Jefferson/Deschutes
 counties and there was a public meeting to discuss the watershed plan and is out for public
 comment.
- Victoria Fischella (CREP): Victoria has secured funding for the next biennium for a full-time CREP position for the tri-county area. On November 13-15, CREP planted 2,200 riparian plants along the Deschutes River (Tumalo area) and executed 90 acres of Juniper removal. CREP has a lot of interest from private landowners along South Fork Crooked River, Antelope Creek, and Little Bear Creek. Victoria will be focusing the end of this biennium (12/31/2019) on finishing up loose ends on current projects and submitting an end of biennium project completion report required by OWEB.
